# If You Gave Elementary School Students \$2K, How Would They Spend It? (Education Week)

Excerpt from the article: "A new bathroom mirror. Sports equipment. A game room. A vending machine that dispenses healthy snacks—with proceeds funding future field trips. That's some of what students in the Roosevelt Elementary school district, a K-8 school system of about 7,500 students in Phoenix, voted to invest in when the district gave about half its schools \$2,000 to spend as part of a pilot program in student participatory budgeting."
